Training Beyond Compare

Class 1F - Armed Guard (CIT Industry)

This course is intended to provide basic knowledge for any person wishing to seek employment within the security industry as an armed guard performing Cash in Transit duties. The course includes information covering the duties of a security guard associated with duties requiring the carriage of a Firearm specifically for the Cash In Transit Industry and is a mandatory requirement for pre-licensing.

Target Audience:

Any person wishing to seek employment within the security industry as an Armed Guard performing Cash in Transit duties for an approved CIT employer.

Objectives:

At the end of this course the participant will be able to apply for a 1 year Provisional security licence. Within 12 months of receiving your licence you will be required to upgrade to a Certificate III by way of Workplace Assessments.

Pre-requisites

- You must be over 18 years of age to apply for a Security Licence
- You must be an Australian Permanent Resident or Citizen
- You must pass a Literacy and Numeracy Test.
- You must be able to demonstrate an ability to speak, read and write in English to an acceptable level.
- You must complete the NSW Police Force forms—P1016, read Fact Sheet No. 6 and on your application form declare by agreeing that you understand these.

Note : *You must have an offer of employment from an Approved CIT Employer before you can undertake this course.*

This course activity is designed for any person who wishes to undertake their Pre-Licence—Certificate I in Security Operations and wishes to follow the pathway to upgrade to the Certificate III level for the purpose of completing the mandatory requirements to be eligible for application to a Class 1F—Full Licence.
