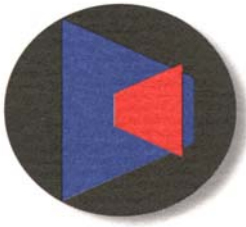

PRINCIPAL AGREEMENT

TERMS & CONDITIONS

- (A) A member within the meaning of this agreement is entitled to the range of benefits described in the membership offer document
- (B) The membership offer document benefits originally disclosed in the original offer document may from time to time change in accordance with notifications specified in the relevant issue of Intercept Group Pty Ltd Newsletters
- (C) That the free initial legal advice referred to in the membership offer document is limited to advice within the Legal expertise available at that time
- (D) The free advice will be provided by Roland Day, solicitor, unless otherwise referred to another Legal Practitioner with appropriate expertise
- (E) That it is acknowledged that there may be occasions and times when advice is not available due to unforeseen circumstances
- (F) That in any case where advice is not so available the member will leave a message on the message bank of the advice providers telephone service
- (G) That the member will be contacted as soon as possible pursuant to any message requesting such contact by the said member
- (H) The extent of the expertise available is a matter for the advice service provider prescribed in (I) above or such other advice service provider referred to the member by Intercept Group Pty Ltd
- (I) That the advice service provider may be unable to provide advice due to lack of expertise in the particular field of law concerned
- (J) That the member acknowledges that in the event that advice is sought and received it is a matter for the member whether such advice is followed/adopted or otherwise
- (K) That it is acknowledged by the member that such advice is provided with all due diligence and care
- (L) It is acknowledged that the intention behind this membership offer is to protect the careers and qualifications of the members by protecting the member from legal processes that may affect the members security, firearms, motor vehicle, water craft, machinery or other licence(s)
- (M) That the free preparation of statements for police investigations refers only to the statement or statements prepared for the member and not the members witnesses
